## **Discussion Notes:**

The meeting was held in-person for the purposes of giving CLC members a facility tour for the first time since the pandemic. The meeting began with a roundtable of introductions, an overview of the agenda, a land acknowledgement and a safety moment about fall safety tips.

Cutler explained that there were no planned alarms for the evening and shared the process to evacuate the facility if an alarm did sound on the facility tour.



Cutler shared with the committee that an open co-chair position is still available and she will remind other members not in attendance at a future meeting or in future correspondence.

Cutler then asked the committee if they had anything to share regarding community feedback about BWXT before providing a BWXT update. No community concerns were raised or tabled.

Cutler then shared that the public attitude survey mailer was recently shipped to 6500 neighbours surrounding the facility and that we were promoting it on Facebook and our website as well. A CLC member shared that he received the mailer in his mailbox.

Cutler then asked members if there were any suggestions for guest speakers and gave an example of having someone from the Nuclear Waste Management Organization come to present on their proposed plans for long term storage.

A member suggested we BWXT connect with the Davenport MP and MPP to ensure BWXT's events and updates are included in their regular mailed/emailed updates. Cutler shared that this has occurred from time-to-time as we update elected officials each month as part of our public information program.

Cutler then shared that an emergency drill was held on June 9<sup>th</sup> and that the CNSC was present as an observer. A member was present for an earlier exercise in 2021 and shared positive feedback about his observations. Another CLC member shared that drills like BWXT's helps the Toronto Fire Services prepare for real-life scenarios and acknowledged how valuable it is for both parties.

Cutler then shared that Chong attended the Western Technical Commercial School graduation ceremony to present the BWXT-sponsored student award.

Cutler shared that BWXT will participate in the CNSC's Regulatory Oversight Review meeting on December 16<sup>th</sup> to review our annual performance and that the meeting will be broadcast live.

Cutler then shared that BWXT would be holding a community webinar on November 3<sup>rd</sup> in lieu of an in-person event, like a BBQ, due to the pandemic. Cutler shared that the webinar would help inform members of the community about BWXT's operations and that the event would be promoted using boosted Facebook ads. Cutler shared that a recording would be posted on our website for those who missed the live event.

Cutler then shared the personal protective requirements for the facility tour and Snopek provided an overview of the hazards to be aware of. The group exited the meeting to commence the tour.

Following the tour, Cutler asked if there were any questions not addressed on the tour and a member suggested we discuss radiation sources at a future meeting, including radon from the basement of a home.

The meeting concluded.
